I believe the work is far from over as we continue to fight for our students. I have been dedicated to ensuring that every student has access to the highest quality education. My focus has always been on student achievement, student safety and supporting staff to include fostering a safe, innovative and nurturing environment. In closing, I want to ensure we create an equitable education for all students in our District, improving upon student outcomes and overall community well-being.

According to the most recent test results, only 23% of 8th grade students met or exceeded math expectations and only 45% met or exceeded English Language Arts (ELA) expectations. With so many of our students failing basic reading and math, it's no surprise that 39% of Richland One high school graduates are not career or college ready.

In light of these results, is the current superintendent meeting expectations? Please explain how he is or is not.

The South Carolina Ready Test is a completely different measurement from the college and career readiness test. It measures different things so there is no correlation between what an eight grader scores on an ELA or math and whether or not they are college and career ready.

The State average for 8th grade students who met or exceed math expectations is 30.3% and 50.3% for ELA. Although our scores are not where I would like to see them, we recognize that due to Covid, 8th graders statewide saw a decrease in scores.

With the challenges our students are facing everyday (high poverty/ homelessness, community violence, special education needs, etc.), these test results are only a snapshot of what our students can do. State Standardized Test are utilized for accountability at the federal and state levels, but as educators will tell you, formative assessments help measure progress in real time. This is why the SC Legislature has worked over the last several years to reduce the number of standardized tests and move towards allowing more formative assessments that measure growth.

Our current administration has placed an emphasis on college and career readiness and growing our students to their potential and their dreams. We have implemented Summer SOAR and other summer camps to address student achievement and I am confident that we will see an increase in these scores.

Per the State Inspector General's report, Richland One "mismanaged" \$31 million related to the Vince Ford Early Learning Center. This mismanagement led the <u>State Superintendent</u> to elevate the district from "fiscal watch" to "fiscal caution."

What would you recommend as the course of action for this particular project?

The early learning center has been discussed in our strategic plan since 2014 and funding was approved during the 2022 school year. I acknowledge that construction started before the necessary permits were obtained. Although it's common practice to allow school districts to advance construction projects without a formal permit as reported and documented by the state Inspector General's report on page 21, I will ensure the district will comply with securing necessary permits for future projects. Additionally, as a board member I will continue to work together with the various entities to ensure the district remains in compliance with all regulations.

Additionally, the board has quarterly work sessions that are open to the public to ensure transparency. At these work sessions, we discuss topics in detail to get an in-depth understanding of the specific issues. I will continue to encourage the public to participate in these work sessions to help build trust and confidence in the board.
